Notice of Partial Revision to the Articles of Incorporation

Tokyo, Japan—May 9, 2013—FUJISOFT INCORPORATED ("the Company") announces that, at a meeting of its Board of Directors held today, the Company resolved to propose partial revisions to the Articles of Incorporation to the 43rd ordinary general meeting of shareholders, scheduled to be held on June 24, 2013. Details are as follows.

1. Reasons for the revisions

The Company's fiscal year is from April 1 to March 31 of the following year. However, to improve the efficiency of operating results administration and business management by avoiding the overlapping of busy business seasons and a period when the Company is engaged in administrative operations related to settlement results and other matters, and to reinforce the appropriate and timely disclosure of management information by changing the settlement period to the same period as that used by its overseas subsidiaries, in light of expanding globalization of its operations in the future, the Company has determined it will change its fiscal year to a period from January 1 to December 31.

Accordingly, the Company will revise provisions set out in Articles 11, 12, 31 and 33 of the present Articles of Incorporation.

Moreover, as a result of the above change, because the 44th fiscal year will be a nine-month period from April 1, 2013 to December 31, 2013, the Company has set out supplementary provisions as transitional measures.
